This agreement is between ZoomAlbum Inc. which is engaged in the sales of photo album supplies and related products, hereafter called "the Company", and _____, hereafter called "the Photobook Coach".

The Photobook Coach enters in to this one-year agreement with the Company as an independent contractor for the purposes of purchasing products for personal use and/or resale. The Photobook Coach certifies that he/she is at least 18 years of age.

All taxes and or expenses associated with purchasing and selling products from the Company are the sole responsibility of the Photobook Coach. The Company shall not be held responsible for any damages incurred to or by the Photobook Coach. The Photobook Coach will not be treated as an employee for federal or state tax purposes. The Company is committed to in-home workshops and related methods of sale (bazaars, crops, retreats etc.) as the most effective ways to promote the Company's products. ZoomAlbum Inc. does not permit the selling of currently available products on eBay or any other auction site by any Photobook Coach. Photobook Coaches are permitted to use products purchased from the Company to make their own ZoomAlbums or to sell to their friends and customers.

If the Photobook Coach chooses to sell products, all advertising media (paper, radio, TV, internet, flyers) shall be approved by the Company before the advertising is used or printed for use. All advertising media shall be produced using the provided logo materials and state that the advertiser is an Independent Consultant with the Company. All advertising media must follow branding guidelines provided by the Company. Photobook Coaches are eligible to receive compensation for recruiting or referring new Photobook Coaches to the Company.

All orders placed by the Photobook Coach are to be paid prior to shipping. Order amounts are based on selling price of the product minus a 30% commission. Shipping and handling is charged in addition to the product price.

The Photobook Coach agrees to conduct his/her sales and activities in a fair and ethical manner including submitting and delivering customer orders in a timely manner (within seven days). It is incumbent upon Photobook Coaches to conduct themselves in a manner that will reflect positively upon the Company. Violation of these terms in any way may result in the Photobook Coach's termination from the Company.

This agreement will be in effect for one year, and shall renew annually thereafter so long as:

- The Photobook Coach is in compliance with this agreement
- This agreement has not been terminated by the Photobook Coach or the Company

The Photobook Coach agrees to read and abide by all policies, procedures and guidelines provided by the Company. By a written notice, either party may cancel this agreement at any time. By signing this agreement, the Photobook Coach acknowledges the terms and conditions set forth within this agreement and will abide by its terms, as well as any new policies created during the Photobook Coach's involvement with the Company.
